*No member shall be eligible for office unless he/she has been a member of Local 102 in continuous good standing for at least two (2) years immediately prior to nomination. (Local 102 Bylaws, Article III, Section 7, Subsection-e)

*Anyone desiring to be nominated must be present during the nominations or provide a written and signed statement that they will accept the nomination. (IBEW Constitution, Article XVI, Sec. 10)

*The Business Manager and President shall by virtue of their office serve as a delegate to the International Convention. (Local 102 Bylaws, Article VIII, Sec. 3 & 4)

ELECTIONS

A secret ballot election for the offices of President, Vice President, Recording Secretary, Financial Secretary, Treasurer, Business Manager, Executive Board Members (6), Delegates to the International Convention (7) and Alternate Delegates (2) is being conducted by mail. Ballots for this election are being mailed to all members on Thursday, May 14, 2020. Any member who has not received a ballot in the mail at home by Thursday, May 21, 2020 **or any member who spoils a ballot** may request a new ballot by contacting Electec Election Services, Inc. at **609-265-8181 (ext.2015) or 1-800-833-9912. If you request and return another ballot, only one ballot will be counted.**

Alternate Plans

Plan A

3. For those who would prefer not to come into the building, the election judge will make arrangements for drive-up nominations. A station will be set up in the garage underneath our main office at 50 Parsippany Road.
4. You may nominate yourself. You **DO NOT** need to bring someone with you to nominate you.
5. Barry Checinski is the Election Judge; his cell number is 551-206-1773. If a teller is not available when you arrive please contact Brother Checinski and he will assist you.
6. A brief meeting will be held at 7:00pm with an abbreviated agenda so that the nominations may be recorded into the minutes. You **WILL NOT** be required to be at the meeting in order to be nominated. Due to possible restrictions at that time the attendance for the meeting may also need to be limited.
7. A representative from the Department of Labor, State Board of Mediation is scheduled to be on hand along with Electec Election Services, Inc.

Please note that the purpose of this process is to allow ample time for nominations while adhering to social distancing.
